Invitation for Bids for the **Construction of Blacktop Roads on ward no. 4,5,6 and 7**

1. The Government of Nepal [GoN] **has allocated funds** from [GoN] towards the cost of **Construction of Blacktop Roads on ward no. 4,5,6 and 7** and intends to apply part of the funds to cover eligible payments under the Contract **20/Road/Kamal/076/77**. Bidding is open to all eligible as per Section V of bidding document..
2. **Kamal Rural Municipality, Topgachhi, Jhapa** invites electronic bids from eligible bidders for the construction of **Cross-Drainage Works, Structural works, Drain works,, traffic safety and Blacktop(Premix and Asphalt Concrete) work.** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 90 Millions**
  - Minimum Work experience of similar size and nature: **NRs 110 Millions**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at **Kamal Rural Municipality, Topgachhi, Jhapa** at **26 Jan, 2020, 01:00 Pm.**
7. Electronic bids must be submitted to the office **Kamal Rural Municipality, Topgachhi, Jhapa** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00PM** on **4th Feb, 2020 (2076/10/21)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **01:00PM, 4th Feb 2020 (2076/10/21)** at the office of **Kamal Rural Municipality, Topgachhi, Jhapa**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 35,00,000**, which shall be valid for **30 days** beyond the validity period of the bid.  
If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
