Invitation for Bids for the **Construction Work on Topgachhi Water Supply Scheme no.2**

1. The Government of Nepal [GoN] **has allocated funds** from [GoN] towards the cost of **Construction Work on Topgachhi Water Supply Scheme no.2** and intends to apply part of the funds to cover eligible payments under the Contract **21/Watersupply/Kamal/076/77**. Bidding is open to all eligible as per Section V of bidding document.
2. **Kamal Rural Municipality, Topgachhi, Jhapa** invites electronic bids from eligible bidders for the construction of **Over head tank, Pipeline laying, Boring, Water Treatment plant, Pump house etc work.** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 76 Millions**
 - Minimum Work experience of similar size and nature: **NRs 95 Millions**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders, submitting their bid electronically, should deposit the cost of bidding document **NRs 10,000** in the Project's Rajaswa (revenue) account as specified below

6. Pre-bid meeting shall be held at **Kamal Rural Municipality, Topgachhi, Jhapa** at **04 Feb, 2020, 01:00 Pm.**
7. Electronic bids must be submitted to the office **Kamal Rural Municipality, Topgachhi, Jhapa** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00PM** on **14th Feb, 2020 (2076/11/02)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **01:00PM, 14th Feb 2020 (2076/11/02)** at the office of **Kamal Rural Municipality, Topgachhi, Jhapa**. Bids must be valid for a period of **150 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 30,00,000**, which shall be valid for **30 days**

beyond the validity period of the bid.

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
