The bidswill be opened in the presence of Bidders' representatives who choose to attend at 14:00, 2077/02/30 (2020/06/12). at the office of Kamal Rural Municipality, province No. 1, Topgachhi Jhapa. Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security amount as stated above deposited at Dharauti account No. 0640058196400081 on behalf of of Kamal Rural Municipality at NMB Bank, Kerkha branch or bid bond authorized from a recognized "A" class commercial bank or Finincial institution eligible to issue bank guarantee as per prevailing law of Nepal.
