Scanned copy (pdf format) of bank voucher/receipt, bidders company/form registration certificate, VAT/PAN registration and Tax clearance certificate of F/Y 075/076 should be uploaded by the bidder at the time of electronic submission of bid. In case of pipeline, manufacture company/firm certificate, Quality standard award certificate, in suppliers/firm case Manufacturer's Authorization letter is essential.
