- 5. Electronic bids must be submitted to the office Kamal Rural Municipality, Topgachhi, Jhapa through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00Pm on 14-Feb-2021 (2077/11/2). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 01:00 PM, 14-Feb-2021 (2077/11/2) at the office of Kamal Rural Municipality, Topgachhi, Jhapa.Bids must be valid for a periodof120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 45,00,000 which shall be valid for 30 days beyond the validity period of the bid.
