- 5. Sealed bids must be submitted to the office *of Kamal Rural Municipality, 1 No. Province, Topgachhi, Jhapa* by hand/courier on or before *time mention in above table.* Bids received after this deadline will be rejected.
- 6. The sealed bids will be opened in the presence of Bidders' representatives who choose to attend at *time mention above* at the office of *Kamal Rural Municipality, 1 No. Province, Topgchhi, Jhapa*. Bids must be valid for a period of *90 and 45 daya for the NCB works and NCB goods respectively* after bid opening and must be accompanied by a bid security amounting to a minimum amount as mention above table, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
